Byte Back offers a wide range of computer training, from basic computer literacy to information technology (IT) certification courses; as well as job readiness skills and job placement assistance. Instructors are volunteers. Low-income students receive free instruction and a free refurbished computer upon graduation. During fiscal year 2011, Byte Back taught classes to more than 1,000 students. Additionally, Byte Back provided training for IT certification to over 100 students. Byte Back is a licensed postsecondary educational institution. In 2010, Byte Back won Honorable Mention for the Washington Post Award for Excellence in Nonprofit Management and was selected for inclusion in the 2010-2011 Catalogue for Philanthropy.
