1 Briefly describe the organization's mission: Byte Back's mission is to improve economic opportunity for low-income residents of the Washington DC area by providing computer training and employment readiness skills.

4a (Code:) (Expenses \$ 370,913. including grants of \$) (Revenue \$ 364,099.) Computer Literacy: Our PC for Beginners course teaches simple tasks such as how to use a keyboard and mouse as well as practical skills such as how to research a health condition on-line or communicate via email. We offer customized classes for Spanish-speakers, senior citizens, and literacy learners. In FY14, 680 students enrolled in computer literacy classes; 80.4% of those completed the class. 257 students participated in one-time workshops on topics such as Google Tools, Facebook & Twitter, and Preparing for the Computer-Based GED Exam.

4b (Code:) (Expenses \$ 875,539. including grants of \$) (Revenue \$ 878,784.) Career Development: We offer Microsoft Office, as well as other classes such as QuickBooks and HTML that enable students to explore new careers and move up the career ladder. Our certification classes allow low-income job seekers to qualify for growth industry jobs in the Information Technology and Business Services fields. Byte Back also provides tutoring mentoring, career counseling, hands-on-internships and job placement assistance. In FY14, 628 students enrolled in career development classes; 76.3% completed the class. Among those who completed, \$18.96 was the average hourly wage of Certification students, \$14.79 for Office Track (Microsoft Office) students.

4c (Code:) (Expenses \$ 183,612. including grants of \$) (Revenue \$ 94,853.) First Time Technology: Our certification interns refurbish and recycle used computers, providing students with valuable hands-on jobs training and creating hundreds of usable computers that can be distributed throughout low income communities. Interns rotate through a sequence of workstations, learning new skills at each stage, including computer troubleshooting and repair. After their internships are completed, their new skills enable them to pass their certification exams and to secure jobs in the IT field with opportunities for advancement. Refurbished computers are awarded to low income graduates of Byte Back courses so they may practice their new skills. They are also sold below cost to low-income families and to nonprofit organizations which serve them. Byte Back refurbished 576 computers last year.
