Byte Back's mission is to improve economic opportunity for low-income residents of the Washington DC area by providing computer training and employment readiness skills.

Byte Back teaches two digital literacy levels, helping hundreds of DC residents gain skills in technology every year. (1) PC for Beginners is designed for students with no or minimal computer experience. In FY17, Byte Back had 404 student enrollments in 43 PC for Beginners courses. In the class, students learn to use a computer and the Internet. (2) The intermediate class, Microsoft Office Track, instructs students in Word, Excel, PowerPoint, and Outlook. In FY17, there were 175 student enrollments in 17 Office Track classes. Office Track offers the skills needed for an entry level office position. Classes for all digital literacy courses are offered in English and Spanish.

4b (Code:) (Expenses \$ 385,734. including grants of \$) (Revenue \$ 8,422.)
Certification classes are free and industry-recognized courses to prepare students for a living wage career in technology and business services. They include CompTIA A+, CompTIA IT Fundamentals, Microsoft Office Specialist (MOS) Excel and Microsoft Office Specialist (MOS) Outlook. In FY17, Byte Back enrolled 172 students in 16 certification courses; 55 students earned certifications.

Byte Back offers career services to students in intermediate and advanced classes, including individual sessions with Byte Back specialists to strategize employment search needs and implement customized job seeking support (e.g. mentoring, mock interviews, and resume writing). Sixty students reported obtaining new positions and saw an average \$24,000 increase in their annual incomes after coming to Byte Back.
